This bibliography contains a diverse selection of articles, books, chapters, and professional and/or governmental publications that covers literature in English related to sexual harassment, sexual assault, and discrimination in regard to writing studies. While the list touches on issues of intersectionality in terms of gender, race, class, language, ethnicity, religion, etc., the main focus remains on documents whose central subject is sexual harassment, sexual assault, or sexual discrimination. The terminus ad quo is 1964, beginning with the Civil Rights Movement, and ends in 2018. Because the topics of sexual harassment, sexual assault, and discrimination are so extensive and covered in depth across a range of academic literatures, this bibliography is meant to serve as a starting point for the researcher. Included here are useful search terms with which to begin a database search. This list is drawn from most common search terms based on Library of Congress subject headings, the Google AdWords Keyword Tool, and Wordtracker.com.
